Dear Friends,

When a child enters the foster care system, everything can feel uncertain. CASA of San Bernardino County responds by recruiting, training, and supporting volunteer advocates who stand beside children who have experienced abuse or neglect. These advocates provide stability, advocate for each child's best interests in court, and support their path toward safe and stable futures.

Currently, we have 320 youth under San Bernardino County court jurisdiction on our waitlist. They are spread out across 63 cities and 7 counties, creating major barriers to consistent advocacy and volunteer matching. However, we are staunch in our belief that each one deserves a caring adult who will listen, show up, and remain by their side through the court process and beyond, and we are committed to making that a reality.

Support from community partners is essential to this work. Private funding allows CASA to serve more children, train volunteers, and provide the ongoing guidance needed to ensure every volunteer advocate can make a meaningful difference.

We hope you will join us for the Change A Child's Story Gala, where community leaders, partners, and supporters will come together and champion children who deserve hope and stability. Funds raised will directly support volunteer recruitment, training, and ongoing supervision so that every child served by CASA has a strong and consistent voice.

Your generosity makes it possible for CASA volunteers to show up—again and again—for children whose lives have been shaped by uncertainty, trauma, and loss. Each gift below directly changes a child’s story by providing consistency, advocacy, and hope.

CASA Volunteer Recruitment & Training Donor — \$15,000

Right now, more than **320 children** in our community are waiting for someone to stand up for them.

This gift fuels the recruitment, screening, and training of new CASA volunteers—turning compassion into action and ensuring that more children have a trusted adult by their side during the most critical moments of their lives.

Dedicated Driver Donor — \$10,000

For many children in foster care, consistency is rare—but a CASA volunteer keeps showing up.

Volunteers drive an average of **70+ miles** per visit to make sure their child is not forgotten. This gift covers transportation for **1,600+ miles**, ensuring that distance never stands in the way of connection, trust, and stability.

Alumni Advancement Donor — \$5,000

When a child ages out of foster care, their need for support doesn’t disappear—it often grows.

This gift helps former CASA youth take their next steps into adulthood by providing essentials like driver’s training, laptops, work clothing, certifications, home furnishings, and baby supplies. It means believing in them after the system says goodbye.
